Timothy Naughton is Chairman, Chief Executive Officer and President of AvalonBay Communities. He has served as Chairman of the Board since May 2013, CEO since January 2012, and as President since February 2005. Previously, Tim served as COO since February 2001. He has been a director of the Company since September 2005. Prior to becoming COO, Tim served as Senior Vice President and Chief Investment Officer, and prior to that he was the Company's Regional Vice President, Development and Acquisitions in the Mid-Atlantic and Midwest.

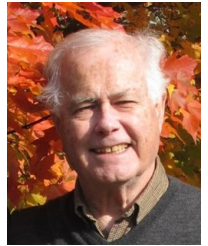


Tim has served on the board of directors of Health Care REIT since December 2013, serves on the Executive Board of NAREIT, is a member of The Real Estate Round Table, is a member and past chairman of the Multifamily Council of the ULI, and is a member of the National Multi-Housing Council (NMHC).

David C. Leibson

and Arlington's Ten Year Plan to End Homelessness

Dave Leibson has been managing and supporting affordable housing programs in the United States and abroad for more than 45 years. He has been Co-Chair of Arlington County's 10-Year Plan To End Homelessness since 2008 and from 2000-2008 was a member of the County Housing Commission. He is Vice President of the Alliance for Housing Solutions, served on the Working Group for the County's recently adopted Affordable Housing Master Plan and before that the Working Group for the award winning Columbia Pike Land Use and Housing Plan.



A retired Foreign Service Officer, he has held senior positions with the US Agency for International Development, and the Foundation for Cooperative Housing. He and his family lived overseas for more than 20 years where he pioneered squatter settlement improvement and urban improvement programs that reached tens of thousands of families in North and West Africa, the Middle East, Europe, and Asia.

Your contribution matters:

- Arlington has 17,000 low-income households, but **only 9,500 homes affordable** to these households. As a result, 7,500 low-income individuals and families live in overcrowded conditions or are rent-burdened in order to remain in Arlington.
- **Arlington lost 13,500 affordable rental homes from 2000-2013** due to rent increases, demolitions and condo conversions.
- APAH is working to increase the number of affordable housing units in Arlington by at least 200 units per year by acquisition, preservation or new development. **APAH is currently building or developing more than 750 affordable apartments** to keep Arlington diverse and inclusive.
- Thanks to a robust Resident Services department which offers many programs, APAH properties have had a **less than 1% eviction notice over the last three years**. Having a stable home is the first essential step to allow a family to thrive.
